<u>Notification of RSPO Annual Surveillance Assessment – 1.3 of Pondok Labu POM – PT Paripurna Swakarsa a</u> subsidiary of Sime Darby Plantation Bhd (RSPO Membership Number 1-0008-04-000-00 – 7 September 2004)

Dear Stakeholders,

Sime Darby Plantation Bhd has applied to Mutuagung Lestari for RSPO annual surveillance of Pondok Labu POM – PT Paripurna Swakarsa and its supply based, located in Pondok Labu Village, Pamukan Selatan Sub-District, Kotabaru District, Kalimantan Selatan Province, Indonesia against the requirement of Principles and Criteria for the Production of Sustainable Palm Oil 2018, endorsed by the RSPO Board of Govermors and adopted at the 15th Annual General Assembly by RSPO Member on 15 November 2018 and Supply Chain Requirement for CPO Mill, November 2014 revised on 14 June 2017.

Sime Darby Plantation Bhd has been taking an active role in the RSPO certification processes and implementing programme to maintain RSPO Certified Sustainable Palm Oil. Mutuagung Lestari has arranged to conduct the annual surveillance of Pondok Labu POM – PT Paripurna Swakarsa which has 1 (one) mill and 4 (four) oil palm estates on **03 to 08 February 2020**.

PT Mutuagung Lestari, is also known Mutu Certification International (MUTU), and has started as inspection, laboratory, and Certification body since 1990. As a private national company and supported with highly committed professionals, MUTU has gained recognition nationally and internationally. Since June 2003, MUTU has received recognition from the Ministry of Agriculture, Forestry, and Fishery of Japan (MAFF) as registered overseas certification body (ROCB). MUTU certify and mark products with Japan agriculture standard (JAS) covering Indonesia, Myanmar, Cambodia, Malaysia, Vietnam, Timor Leste, Philippines, Papua New Guinea and China. MUTU is the first ROCB in Asia. National Accreditation Committee has accredited MUTU as Quality Management System certification body (ISO 14001:2015). Indonesia Ecolabelling Institute (LEI) has also accredited MUTU as Sustainable Forest Management System certification Body of Indonesian Sustainable Palm Oil (ISPO), Since March 2014, MUTU has been accredited by ASI (Accreditation Services International) as a RSPO certification body.

The assessor team for the certification assessment will be led of **Trismadi Nurbayuto** and other team assessor from PT Mutuagung Lestari

PT Mutuagung Lestari invites stakeholders to provide comments (if any) on any of the following matters related to the site for assessment,

- a. Environmental protection within the estate or mill including use of pesticide and effluent management.
- b. Biodiversity within the estate and mill
- c. Opportunities for employment
- d. Contribution for local development
- e. Provision of housing, sanitation, facility and education support
- f. Other issues related with assessment
