Austindo Nusantara Jaya Agri has applied to Mutuagung Lestari and will conduct initial certification at Kayung Agro Lestari POM and its supply based, located Bandar Laman Satong Village, Matan Hilir Utara Sub-District, Ketapang District, Kalimantan Barat Province, Indonesia against the requirement of Standard Indonesian National Interpretation of RSPO Principles and Criteria 2013 by INA-NITF, July 2016 (Endorsed by the RSPO Board of Governors meeting on 30th September 2016) and Supply Chain Requirement for CPO Mill, November 2014 revised on 14 June 2017.

Kayung Agro Lestari POM – Kayung Agro Lestari has successfully been registered in the PalmTrace IT platform with member ID RSPO\_PO100006366. The organization is a member of RSPO and has been taking an active role in the RSPO certification processes and planned to achieve RSPO Sustainable Palm Oil requirement for all of its production. Mutuagung Lestari has arranged to conduct the assessment to the organization which operating 1 (one) palm oil mill, 5 (five) 14 to 18 Oktober 2019.
