Dear Stakeholders.

Sime Darby Plantation Berhad has applied to Mutuagung Lestari for RSPO annual surveillance of Rantau Panjang POM – PT Guthrie Pecconina Indonesia and its supply based, located in Village of Rantau Panjang, Sub-District of Lawang Wetan, District of Musi Banyuasin, Province of Sumatera Selatan, Indonesia against the requirement of the Standard Indonesian National Interpretation of Principles and Criteria for the Production of Sustainable Palm Oil 2018, endorsed by the RSPO Board of Governors and adopted at the 15<sup>th</sup> Annual General Assembly by RSPO Member on 15 November 2018.

PT Guthrie Pecconina Indonesia has been taking an active role in the RSPO certification processes and implementing programme to maintain RSPO Certified Sustainable Palm Oil. Mutuagung Lestari has arranged to conduct the annual surveillance of Rantau Panjang POM – PT Guthrie Pecconina Indonesia which has 1 (one) palm oil mill and 5 (five) oil palm estates on 24 to 29 February 2020.

PT Mutuagung Lestari, is also known Mutu Certification International (MUTU), and has started as inspection, laboratory, and Certification body since 1990. As a private national company and supported with highly committed professionals, MUTU has gained recognition nationally and internationally. Since June 2003, MUTU has received recognition from the Ministry of Agriculture, Forestry, and Fishery of Japan (MAFF) as registered overseas certification body (ROCB). MUTU certify and mark products with Japan agriculture standard (JAS) covering Indonesia, Myanmar, Cambodia, Malaysia, Vietnam, Timor Leste, Philippines, Papua New Guinea and China.
