Sime Darby Plantation Berhad has applied to Mutuagung Lestari for RSPO annual surveillance to of Sekunyir POM – PT Indotruba Tengah and its supply based, located in Village of Amin Jaya and Pembuang Hulu, Sub District of Pangkalan Banteng and Hanau, District of Kotawaringin Barat and Seruyan, Province of Kalimantan Tengah, Indonesia against the requirement of the Indonesian National Interpretation of RSPO Principles and Criteria 2013 by INA-NITF, July 2016 (Endorsed by the RSPO Board of Governors meeting on 30th September 2016) and Supply Chain Requirement for CPO Mill, November 2014 revised on 14 June 2017.

PT Indotruba Tengah has been taking an active role in the RSPO certification processes and implementing programme to maintain RSPO Certified Sustainable Palm Oil. Mutuagung Lestari has arranged to conduct the annual surveillance of Sekunyir POM – PT Indotruba Tengah which has 1 (one) mill and 2 (two) oil palm estates on **07 to 11 October 2019**.

PT Mutuagung Lestari, is also known Mutu Certification International (MUTU), and has started as inspection, laboratory, and Certification body since 1990. As a private national company and supported with highly committed professionals, MUTU has gained recognition nationally and internationally. Since June 2003, MUTU has received recognition from the Ministry of Agriculture, Forestry, and Fishery of Japan (MAFF) as registered overseas certification body (ROCB). MUTU certify and mark products with Japan agriculture standard (JAS) covering Indonesia, Myanmar, Cambodia, Malaysia, Vietnam, Timor Leste, Philippines, Papua New Guinea and China.
