PT Brahma Binabakti has applied to Mutuagung Lestari and will conduct Re-Certification at Brahma Binabakti POM and its supply based, located at Suko Awinjaya Village, Sekernan Sub-District, Muaro Jambi District, Jambi Province, Indonesia against the requirement of Principles and Criteria for the Production of Sustainable Palm Oil 2018, endorsed by the RSPO Board of Governors and adopted at the 15th Annual General Assembly by RSPO Member on 15 November 2018.

PT Brahma Binabakti has successfully been registered in the PalmTrace IT platform with member ID RSPO\_ PO100001619. The organization is a member of RSPO and has been taking an active role in the RSPO certification processes and planned to maintain RSPO Sustainable Palm Oil requirement for all of its production. Mutuagung Lestari has arranged to conduct the assessment to PT Brahma Binabakti which operating 1 (one) palm oil mill with 1 (one) estate and 1 (one) full managed scheme smallholders on 13 to 18 April 2020.
