Golden Agri Resources Ltd has applied to Mutuagung Lestari and will conduct Re-Certification at PT Satya Kisma Usaha with scope audit Sungai Bengkal POM and its supply based, located at Betung Bedarah Barat Village, Tebo Ilir Sub District, Tebo District, Jambi Province, Indonesia against the requirement of Principles and Criteria for the Production of Sustainable Palm Oil 2018, endorsed by the RSPO Board of Governors and adopted at the 15<sup>th</sup> Annual General Assembly by RSPO Member on 15 November 2018.

Sungai Bengkal POM – PT Satya Kisma Usaha has successfully been registered in the PalmTrace IT platform with member ID RSPO\_PO1000001722. The organization is a member of RSPO and has been taking an active role in the RSPO certification processes and planned to maintain RSPO Sustainable Palm Oil requirement for all of its production. Mutuagung Lestari has arranged to conduct the assessment to the organization which operating 1 (one) palm oil mill and 1 (one) estates on **20 to 24 April 2020.**
