Sime Darby Plantation Berhad has applied to Mutuagung Lestari for RSPO annual surveillance of Bukit Puteri POM – SOU 11 and its supply based, located in K/B31, Sungai Koyan, 27650 Raub, Pahang Darul Makmur, Malaysia against the requirement of the Malaysia National Interpretation (MYNI) 2019 of the RSPO Principles and Criteria 2018 for Sustainable Palm Oil Production.

Sime Darby Plantation Berhad has been taking an active role in the RSPO certification processes and implementing programme to maintain RSPO Certified Sustainable Palm Oil. Mutuagung Lestari has arranged to conduct the annual surveillance of Bukit Puteri POM – SOU 11 which has 1 (one) mill and 1 (one) oil palm estates on 17 to 19 September 2020.

PT Mutuagung Lestari, is also known Mutu Certification International (MUTU), and has started as inspection, laboratory, and Certification body since 1990. As a private national company and supported with highly committed professionals, MUTU has gained recognition nationally and internationally. Since June 2003, MUTU has received recognition from the Ministry of Agriculture, Forestry, and Fishery of Japan (MAFF) as registered overseas certification body (ROCB). Indonesia Ecolabelling Institute (LEI) has also accredited MUTU as Sustainable Forest Management System certification body, Certification Body of Indonesian Sustainable Palm Oil (ISPO), Since March 2014, MUTU has been accredited by ASI (Accreditation Services International) as a RSPO certification body.

The assessor team for the certification assessment will be led of **Mahaswaran Maliyap** and other team assessor from PT Mutuagung Lestari
