Sime Darby Plantation Berhad has applied to Mutuagung Lestari for RSPO annual surveillance of Kok Foh POM – SOU 16 and its supply based, located in 72109 Bahau, State of Negeri Sembilan, Malaysia against the requirement of the Malaysia National Interpretation (MYNI) 2019 of the RSPO Principles and Criteria 2018 for Sustainable Palm Oil Production.

Sime Darby Plantation Berhad has been taking an active role in the RSPO certification processes and implementing programme to maintain RSPO Certified Sustainable Palm Oil. Mutuagung Lestari has arranged to conduct the annual surveillance of Kok Foh POM – SOU 16 which has 1 (one) mill and 7 (seven) oil palm estates on **07 to 11 September 2020**.

PT Mutuagung Lestari, is also known Mutu Certification International (MUTU), and has started as inspection, laboratory, and Certification body since 1990. As a private national company and supported with highly committed professionals, MUTU has gained recognition nationally and internationally.
