LTD has applied to Mutuagung Lestari and will conduct Annual Surveillance Assessment at PT Gandaerah Hendana with scope Gandaerah Hendana POM and its supply base, located in Ukui II Village, Ukui Sub-District, Pelalawan District, Riau Province, Indonesia against the requirement of Indonesia National Interpretation of the RSPO Principles and Criteria for the Production of Sustainable Palm Oil 2018 (INANI 2020).

PT Gandaerah Hendana is a member of RSPO and has been taking an active role in the RSPO surveillance processes and implementing programme to maintain RSPO Certified Sustainable Palm Oil. Mutuagung Lestari has arranged to conduct an assessment to Gandaerah Hendana POM – PT Gandaerah Hendana which operating 1 (one) palm oil mill and 3 (three) oil palm estates on **27 April to 01 May 2021**.

PT Mutuagung Lestari, is also known Mutu Certification International (MUTU), and has started as inspection, laboratory, and Certification body since 1990. As a private national company and supported with highly committed professionals, MUTU has gained recognition nationally and internationally.
