PT Brahma Binabakti is an oil palm plantation company that was established in 1988 in accordance with the *Akta Notaris* DR. H. E. Gewang, S.H No. 10 dated November 9, 1988 which has been ratified by the Minister of Justice of the Republic of Indonesia by Decree no. 02.3119.HT.01.01 dated April 10, 1989.

PT Brahma Binabakti not clearing land above November 2005. The land clearing was conducted on 1995 -1998. This is accordance with email from RSPO dated on March 16, 2018 (PT Brahma Binabakti with own estate) has disclosed with zero non-compliant land clearance.

PT Mutuagung Lestari, is also known Mutu Certification International (MUTU), and has started as inspection, laboratory, and Certification body since 1990. As a private national company and supported with highly committed professionals, MUTU has gained recognition nationally and internationally.
