The organization is a member of RSPO and has been taking an active role in the RSPO certification processes and planned to achieve RSPO Sustainable Palm Oil requirement for all of its production. Mutuagung Lestari has arranged to conduct the assessment to the organization which operating 1 (one) palm oil mill, and 2 (two) estate on **27 September to 01 October 2021**.

No. 135, dated July 29, 1987 and has obtained approval from the Director General of Law and Legislation on behalf of the Minister of Justice of the Republic of Indonesia No. C2-8332.HT.01.01.Th.'88 dated 9 September 1988. There was no land clearing above November 2005, the planting year for PT Surya Intisari Raya was 1993 -2004.
