Bumitama Agri Ltd has applied to Mutuagung Lestari and will conduct Annual Surveillance Assessment at PT Karya Makmur Bahagia with scope Gunung Makmur POM and its supply base, located in Rantau Tampang Village, Telaga Antang Sub-District, Kotawaringin Timur District, Kalimantan Tengah Province, Indonesia against the requirement of Indonesia National Interpretation of the RSPO Principles and Criteria for the Production of Sustainable Palm Oil 2018 (INANI 2020).

PT Karya Makmur Bahagia is a member of RSPO and has been taking an active role in the RSPO surveillance processes and implementing programme to maintain RSPO Certified Sustainable Palm Oil. Mutuagung Lestari has arranged to conduct an assessment to Gunung Makmur POM – PT Karya Makmur Bahagia which operating 1 (one) palm oil mill and 3 (three) oil palm estates on **06 to 14 June 2021.**
