Dear Stakeholders,

PT Gunajaya Karya Gemilang has applied to Mutuagung Lestari and will conduct Re-Certification at Kendawangan POM and its supply based, located at Banjarsari Village, Kendawangan Sub District, Ketapang District, Kalimantan Barat Province, Indonesia against the requirement of Indonesia National Interpretation of the RSPO Principles and Criteria for the Production of Sustainable Palm Oil 2018 (INANI 2020).

Kendawangan POM – PT Gunajaya Karya Gemilang has successfully been registered in the PalmTrace IT platform with member RSPO\_PO1000003491. The organization is a member of RSPO and has been taking an active role in the RSPO certification processes and planned to maintain RSPO Sustainable Palm Oil requirement for all of its production. Mutuagung Lestari has arranged to conduct the assessment to the organization which operating 1 (one) palm oil mill and 6 (six) estates on **29 November to 03 December 2021**.

Bumitama Agri Ltd founded in 1996 and listed on the Singapore Exchange in 2012, is one of the leading producers of crude

palm oil (CPO) and palm kernel (PK) in Indonesia. The Group harvesting is principally engaged in the cultivation of oil palm trees, as well as the harvesting and processing of fresh palm fruit bunches (FFB) into CPO and PK, which are then sold to refineries in Indonesia. As of 31 December 2020, total planted area is 187,917 hectares and operate 14 CPO mills with a combined processing capacity of 6.03 million tonnes of fresh fruit bunches annually.

PT Gunajaya Karya Gemilang is undergoing the RaCP process. RaCP has been submitted to RSPO with conditional approval status until December 2021.

PT Mutuagung Lestari, is also known Mutu Certification International (MUTU), and has started as inspection, laboratory, and Certification body since 1990. As a private national company and supported with highly committed professionals, MUTU has gained recognition nationally and internationally. Since June 2003, MUTU has received recognition from the Ministry of Agriculture, Forestry, and Fishery of Japan (MAFF) as registered overseas certification body (ROCB). MUTU certify and mark products with Japan agriculture standard (JAS) covering Indonesia, Myanmar, Cambodia, Malaysia, Vietnam, Timor Leste, Philippines, Papua New Guinea and China. MUTU is the first ROCB in Asia. National Accreditation Committee has accredited MUTU as Quality Management System certification body (ISO 9001:2015) and Environmental Management System certification body (ISO 14001:2015).
