




Figure 2. Location Map of KUD Karya Mandiri in Jambi Province







Figure 3. Operational Map of of KUD Karya Mandiri

During internal audit there are several non-conformities regarding RSPO Independent Smallholders Standards, for example several members don't know KUD Karya Mandiri legal documents, farmers don't properly record harvesting activity and etc. Based on documents verification all non-conformity has been evaluated and follow up by organizations prior external audit carried out. Interview with Group Manager obtained information if internal audit divided to several stages become more effective and optimize the available resources / manpower.

Milestone B

The mechanism for Internal Audit ruled in the Procedure of Internal Audit (No 12/SOP/ICS/KUD-KM/XI/2020 dated 05 November 2020) the purpose of that's procedure is to ensure all RSPO certification program members and KUD Karya Mandiri have been ready and complied all indicator RSPO for Independent Smallholders. Based on interviews with farmers, the Group Manager, Village Head, and Plantation Agency obtained information if KUD Karya Mandiri land originated from *Transmigrasi Swakarsa Mandiri* | Self – Directed Transmigration which started on 18 August 1994 with the participants from Province of Jawa Tengah, Jawa Timur, Lampung, Jambi (Local Transmigration). Participants of Self–Directed Transmigration obtained 3 land parcels/plots as follows 0.1 ha for housing/yard, 0.4 ha for *Lahan Usaha 1* | Business Land 1, and 2 Ha for *Lahan Usaha 2* | Business Land 2.

Based on information from stakeholders it was known previously *Lahan Usaha* 2 / Business Land 2 which managed in collaboration with PT Bahari Gembira Ria as smallholders' scheme under KUD Marga Jaya, Village of Petaling Jaya. In 2009, there are blossoming (*pemekara*n) of Village of Petaling Jaya, and this area became the Village of Trimulya Jaya, its due to the blossoming of the village, KUD Karya Mandiri ar established in Village of Trimulya Jaya with the members of KUD are ex KUD Margajaya members with domiciled in Trimulya Jaya Village. The scheme of smallholders with PT Bahari Gembira Ria currently has been ended and the entire area managed by smallholders with the obligation of FFB that produced sold to PT Bahari Gembira Ria

All certification area of KUD karya Mandiri that consists of 275 members; 313 farmers plots/parcels with 625.0472 ha has been obtained freehold title and currently, there are several lands parcels/plots that the original owner has been changed due to the original landowners have been died or sold to new owners.

The assessment will be carried out on 18-28 February 2021. The assessment is carried out by means of a ground check and direct interview. From the results of the HCV assessment, it is known that HCV 1, 4, and 5.

As for the scope of certification covering an area of 625.0472 Ha, only HCV 1 was identified (Biodiversity includes endemic and rare, threatened, or significantly threatened species) several types of flora and fauna found in the scope of certification including *Elang Hitam, Sepah Raja, Raja udang, Burung Madu, Elang Alap-alap.*

KUD Karya Mandiri already has a management plan for the 2020/2021 High Conservation Value Area. Some of the planned activities include Area boundary marking, prevention and control of land fire hazards, area protection and flora and fauna species. Trench area rehabilitation, trench maintenance. The types of derivative activities that will be carried out include making signboards prohibiting land clearing by burning, installing signboards against spraying completely, prohibiting hunting signboards, planting woody plants in ditches/canal/river border areas, mechanical maintenance.

While examples of HCV socialization activities to workers and land owners have been carried out on

- Training related to HCV/HCV on January 25, 2021 which was attended by 23 training participants.
- Fire control training on January 14, 2021 which was attended by 18 trainees.
