First Resources Ltd has applied to Mutuagung Lestari and will conduct Annual PT Subur Arum Makmur with scope Subur Arum Makmur POM and its supply base, located in Danau Lancang Village, Tapung Hulu Sub-District, Kampar District, Riau Province, Indonesia against Surveillance Assessment at PT the requirement of Indonesia National Interpretation of the RSPO Principles and Criteria for the Production of Sustainable Palm Oil 2018 (INANI 2020).

PT Subur Arum Makmur is a member of RSPO and has been taking an active role in the RSPO surveillance processes and implementing programme to maintain RSPO Certified Sustainable Palm Oil. Mutuagung Lestari has arranged to conduct an assessment to Subur Arum Makmur POM – PT Subur Arum Makmur which operating 1 (one) palm oil mill and 1 (one) oil palm estates on **22 to 27 November 2021**.
