Austindo Nusantara Jaya Agri has applied to Mutuagung Lestari and will conduct Annual Surveillance Assesment at PT Kayung Agro Lestari with scope Kayung Agro Lestari POM and its supply base, located in Laman Satong Village, Matan Hilir Utara Sub District, Ketapang District, Kalimantan Barat Province, Indonesia against the requirement of Indonesia National Interpretation of the RSPO Principles and Criteria for the Production of Sustainable Palm Oil 2018 (INANI 2020).

PT Kayung Agro Lestari is a member of RSPO and has been taking an active role in the RSPO surveillance processes and implementing programme to maintain RSPO Certified Sustainable Palm Oil. Mutuagung Lestari has arranged to conduct an assessment to Kayung Agro Lestari POM – PT Kayung Agro Lestari which operating 1 (one) palm oil mill, 4 (four) oil palm estates and 1 (one) smallholders on 10 to 16 October 2021.
