Goodhope Asia Holdings Ltd has applied to Mutuagung Lestari and will conduct Annual Surveillance Assessment at PT Agro Bukit with scope Sungai Binti POM and its supply base, located in Natai Baru Village, Mentaya Hilir Utara Sub-District, Kotawaringin District, Kalimantan Tengah Province, Indonesia against the requirement of Indonesia National Interpretation of the RSPO Principles and Criteria for the Production of Sustainable Palm Oil 2018 (INANI 2020).

PT Agro Bukit is a member of RSPO and has been taking an active role in the RSPO surveillance processes and implementing programme to maintain RSPO Certified Sustainable Palm Oil. Mutuagung Lestari has arranged to conduct an assessment to Sungai Binti POM – PT Agro Bukit which operating 1 (one) palm oil mill and 4 (four) oil palm estates on **07 to 12 February 2022.**
