Sime Darby Plantation Berhad has applied to Mutuagung Lestari and will conduct Recertification at PT Langgeng Muaramakmur with scope Bebunga POM and its supply based, located at Binturung Village, Pamukan Utara Sub District, Kotabaru District, Kalimantan Selatan Province, Indonesia against the requirement of Indonesia National Interpretation of the RSPO Principles and Criteria for the Production of Sustainable Palm Oil 2018 (INANI 2020).

Bebunga POM – PT Langgeng Muaramakmur has successfully been registered in the PalmTrace IT platform with member RSPO_PO100000324. The organization is a member of RSPO and has been taking an active role in the RSPO certification processes and planned to maintain RSPO Sustainable Palm Oil requirement for all of its production. Mutuagung Lestari has arranged to conduct the assessment to the organization which operating 1 (one) palm oil mill and 3 (three) estates on **22 to 27 August 2022**.
