PT Windu Nabatindo Abadi and PT Nabatindo Karya Utama a subsidiary Bumitama Agri Ltd (RSPO Membership: 1-0043-07-000-00) has applied to Mutuagung Lestari and will conduct initial certification at Sungai Cempaga POM and its supply bases, located of Tumbang Koling Village, Cempaga Hulu Sub-District, Kotawaringin Timur District, Kalimantan Tengah Province, Indonesia against the requirement of Indonesia National Interpretation of the RSPO Principles and Criteria for the Production of Sustainable Palm Oil 2018 (INANI 2020).

Sungai Cempaga POM has successfully been registered in the PalmTrace system with PalmTrace member ID is RSPO\_PO100004930. The organization is a member of RSPO and has been taking an active role in the RSPO certification processes and planned to achieve RSPO Sustainable Palm Oil requirement for all of its production. Mutuagung Lestari has arranged to conduct the assessment to the organization which operating 1 (one) palm oil mill and 5 (five) estates on 10 to 14 October 2022.
