PT Putera Manunggal Perkasa has applied to Mutuagung Lestari and will conduct Annual Surveillance Assessment with scope Putera Manunggal Perkasa POM and its supply base, located in Womba and Ikana Village, South Afiat Sub District, Maybrat District; Sumano and Benawa 1 Village, Kais Sub District, South Sorong District, West Papua Province, Indonesia against the requirement of Indonesia National Interpretation of the RSPO Principles and Criteria for the Production of Sustainable Palm Oil 2018 (INANI 2020).

PT Putera Manunggal Perkasa is a member of RSPO and has been taking an active role in the RSPO surveillance processes and implementing programme to maintain RSPO Certified Sustainable Palm Oil. Mutuagung Lestari has arranged to conduct an assessment to Putera Manunggal Perkasa POM – PT Putera Manunggal Perkasa which operating 1 (one) palm oil mill and 4 (four) estates on **07 to 14 November 2022.**
