# Notification of RSPO Annual Surveillance Assessment (ASA-3) of Kayung Agro Lestari POM PT Kayung Agro Lestari subsidiary of Austindo Nusantara Jaya Agri (RSPO Membership 1-0032-07-000-00, 27 February 2007)

Dear Stakeholders,

PT Kayung Agro Lestari has applied to Mutuagung Lestari and will conduct Annual Surveillance Assessment with scope Kayung Agro Lestari POM and its supply base, located in Laman Satong Village, Matan Hilir Utara Sub District, Ketapang District, Kalimantan Barat Province, Indonesia against the requirement of Indonesia National Interpretation of the RSPO Principles and Criteria for the Production of Sustainable Palm Oil 2018 (INANI 2020).

PT Kayung Agro Lestari is a member of RSPO and has been taking an active role in the RSPO surveillance processes and implementing programme to maintain RSPO Certified Sustainable Palm Oil. Mutuagung Lestari has arranged to conduct an assessment to Kayung Agro Lestari POM – PT Kayung Agro Lestari which operating 1 (one) palm oil mill and 6 (six) estates on **26 September to 01 October 2022.** 

PT Mutuagung Lestari, is also known Mutu Certification International (MUTU), and has started as inspection, laboratory, and Certification body since 1990. As a private national company and supported with highly committed professionals, MUTU has gained recognition nationally and internationally. Since June 2003, MUTU has received recognition from the Ministry of Agriculture, Forestry, and Fishery of Japan (MAFF) as registered overseas certification body (ROCB). MUTU certify and mark products with Japan agriculture standard (JAS) covering Indonesia, Myanmar, Cambodia, Malaysia, Vietnam, Timor Leste, Philippines, Papua New Guinea and China. MUTU is the first ROCB in Asia. National Accreditation Committee has accredited MUTU as Quality Management System certification body (ISO 9001:2015) and Environmental Management System certification body (ISO 14001:2015). Indonesia Ecolabelling Institute (LEI) has also accredited MUTU as Sustainable Forest Management System certification body, Certification Body of Indonesian Sustainable Palm Oil (ISPO), Since March 2014, MUTU has been accredited by ASI (Accreditation Services International) as a RSPO certification body.

The Auditor team for the certification assessment will be led of Ardiansyah and other team auditor from PT Mutuagung Lestari
