Figure 1. Location Map of Kelompok Tani Tenera





Figure 2. Operational Map of Kelompok Tani Tenera

This assessment conducted for scope of certification covering 223.92 ha Ha 35 members and 93 land Plots.

Document review, aiming to observe the sufficiency of types or substances from required documents. 2. interview, aiming to obtain more detailed information and cross check the information; 3. field observation, aiming to observe directly the sufficiency of implementation on site.

Meeting in the Meeting Room of Kelompok Tani Tenera. Opening meeting was attended by head of association, farmer members and other related personnel.

Stakeholder consultation involved internal and external stakeholders. Stakeholders included those immediately linked with the operation of the certification units such employees, the local government, NGOs, and local communities. Meetings were held with stakeholders to seek their views on the performance of the certification unit with respect to the RSPO requirements and aspects where they considered that improvements could be made. At the start of each meeting, the interviewer explained the purpose of the audit followed by an evaluation of the relationship between the stakeholder and the company before discussions proceeded. The interviewer recorded comments made by stakeholders and these have been incorporated into the assessment findings. The comments made by external stakeholders were also taken into account in the assessment

Commonly, the audit activities went smoothly with good support from the unit management. The presentation of documents is presented quite well by involving related personnel. Closing Meeting conducted the Meeting Room of Kelompok Tani Tenera, its attended by head of association, farmers members and other related personnel and they accepted the result and recommendation by auditors.

Some opportunities for improvement of the results *ASA-4* delivered by the MUTU auditor to the management unit and the results are the subject will be verified at the next assessment phase (*RC*).

Improvement of finding from this assessment is observed by auditor. All information obtained was recorded in Check List of PT Mutuagung Lestari (MUTU) and part of this report

Assessment was conducted with scope of certification 223.92 Ha; 35 members and 93 land Plots. The location of assessment were 1 village. During this assessment the association considered low risk its due to there is considerable heterogeneity in the Group (e.g. members are geographically or jurisdictionally separated from one another, a range of terrains, varying levels of experience of oil palm cultivation among members, diverse sizes of plantations, a range of socioeconomic situations among members, etc.) and additional new members. Sampling method for ASA-4: $\sqrt{35^*}$ (1.): 6 members.

The sampling location consider the issue arose from the review documents, village distribution and stakeholder's consultation that are fundamental and crucial. The smallholders and locations visited by auditor were

3.0 ASSESSMENT FINDINGS

3.1 Summary of Assessment Report of the RSPO Certification

MUTUAGUNG LESTARI has conducted an assessment of Kelompok Tani Tenera operation consisting of thirty-five (35) smallholders.

During the assessment, there were nil (0) Nonconformity were assigned against RISS Indicators and four (4) opportunities for improvement were identified.

MUTUAGUNG LESTARI found that Kelompok Tani Tenera complied with the requirements of RSPO Independent Smallholder Standard, Indonesia National Interpretation for the Production of Sustainable Palm Oil 2020, endorsed by the RSPO Board of Governors on 14 February 2022 and RSPO Certification Systems for Principles & Criteria and RSPO Independent Smallholder Standard Endorsed by the RSPO Board of Governors on 12 November 2020.

Therefore MUTUAGUNG LESTARI Recommends RSPO Certification of compliance is continued.

Based on interview to the smallholders and field observation on their land parcel, they understood the membership requirement and the consequences in RSPO certification, such as aware about membership requirements, such as requirement to be a member, internal audit process, sanction for SOP violation as well as benefit and advantage joint RSPO Certification.

The results of the document review and interviews during the onsite audit, it was found that there were no additional members of the farmer group.

Eligibility

The results of the document review and interviews during the onsite audit, it is known that all members have signed the membership requirements at the time of initial joining the farmer group and have known the membership requirements. The signing of a statement letter to join a farmer group was carried out for the period from February to May 2017, which contained a willingness to join, support and be involved in farmer group membership, a statement of compliance with all regulations, farmer group policy procedures. Support sustainable palm oil and RSPO certification, improve documentation, improve cultivation, environment and society.

Up to ASA-4 there are no new members in the farmer groups. From the results of interviews with several members of farmer groups, it is known that they have understood the requirements of members.

Furthermore as required in new standard of independent smallholders on 03 January 2022 Kelompok Tani Tenera and all members sign smallholders declaration regarding RSPO Certification commitment as mentioned in annex 2

A.2.1

Eligibility

The Kelompok Tani Tenera already has an ICS structure, which is shown in the Decree of the Head of the Kelompok Tani Tenera number 01.II.KT.2017 dated February 1, 2017. The Kelompok Tani Tenera has an Internal Control System policy, including the Internal Audit procedure No. KELOMPOK TANI_TENERA-SOP-IA-21 document endorsed by Head of Kelompok Tani Tenera on July 1st, 2017. The purpose of this procedure is to enforce criteria, methods, responsibilities for the implementation of the RSPO Internal Audit to ensure its effective implementation. The RSPO Internal Audit is conducted once a year by auditors who have attended RSPO internal training and are experienced in RSPO implementation. ICS makes an audit plan made on the internal audit schedule form. Kelompok Tani Tenera checked the level of effectiveness of its implementation in the field, the last being on June 6th, 2022 with a total of 3 discrepancies related to FFB harvest, maintenance of land boundaries and employee health insurance and all of them were followed

up on August 20th, 2022. All non-conformities were monitored by the management Kelompok Tani Tenera so that these findings will not be repeated in the future. In addition, on June 7th, 2022, the Field Extension Unit conducted a socialization of audit understanding which was attended by 13 employees of Kelompok Tani Tenera with the aim of enabling employees to understand the principles and criteria of the RSPO

Head of Kelompok Tani Tenera has obtained knowledge related to ISH standards and Internal Audit training for Independent Smallholders from the Fortasb Indonesia Foundation in collaboration with the RSPO and TUV Rheinland Indonesia which was held in Palembang on February 27th, 2020. In addition, Head of Kelompok Tani Tenera is a member of the Association of Oil Palm Smallholders. In the procedure also mentioned if internal audit conducted at least annually for each member. Based on interviews with farmers sample it was known if work program has disseminated to all *Kelompok Tani* (Farmers Group) and its members. Furthermore, the Group Manager has set a series of SOP as a plan in ICS with the total there are 56 Procedures.

Related to the management of the association, decision making, member requirements, and association operations are regulated in the Memorandum of Association/Articles of Association which ruled contain regulations for members of the organization in carrying out organizational activities.

Based on interview with ICS member and some member of smallholder, it is known that all the decision in the smallholder made from annual meeting with the member. Based on interview with smallholder member, the best management practice is conducted according to the procedure for example the technique for harvesting, upkeep activity, internal audit, and more. Based on the description above, it shows that the farmer have completed the training and can be able to make production reports and FFB transactions

Furthermore, The Kelompok Tani Tenera documents the annual production in the Data document for the Report, the report explains the name of the owner, the area of land, and the monthly production of each owner.

Furthermore Kelompok Tani Tenera can presented FFB selling documents, invoice and weighbridge slips

These procedures have been socialized to all employees before employees working in the field. When members of the Kelompok Tani Tenera join, they are make a statement to follow all the rules, procedures and policies set by the Kelompok Tani Tenera. Support sustainable cooking oil initiatives and RSPO certification and participate in building documentation improvements and improvements in aquaculture, environment and society. For example, a statement letter to join the Kelompok Tani Tenera on behalf of Candra Saputra No. 04/II/KT/2017 01 February 2017

In previous assessment there are OFI regarding opportunity to ensure that all members sign the Farmers Declaration, this OFI has been verify and during audit it was known where as required in new standard of independent smallholders on 03 January 2022 Kelompok Tani Tenera and all members sign smallholders declaration regarding RSPO Certification commitment as mentioned in annex 2

Milestone A

The Kelompok Tani Tenera conducts internal training for its employees to improve their understanding and technical skills in the field. Several technical related trainings in the field include weeding spraying training on June 9, 2022 which was attended by 5 people so that the employee understands how to spraying and ensures that the employee can use PPE properly. On June 8th, 2022, fertilization training for 5 employees was conducted by Head of Kelompok Tani Tenera. In addition, on June 13th, 2022, FFB harvesting training was conducted by Head for 1 Harvest Foreman and 6 Harvest Employees, which aims to enable employees to practice harvesting methods and use PPE properly.

In addition, there is training from external as the organizer of the activity, namely TUV Rheinland on December 20th to 22nd, 2020 in Pangkalan Bun which discusses the RSPO Independent Smallholder Standard, the National Interpretation of Indonesia 2020, management of farmer, certification requirements including understanding of HCV, environmental protection, workers' social welfare, and business operations. Kelompok Tani Tenera consist of consist of 35 smallholders in 93 land parcels and 223.92 ha. In the previous standard (RSPO Independent Smallholder Standard, 6 November 2019) it was stated that the total land owned by individuals is not more than 50 Ha which is the accumulation of the total land ownership wherever the location is located. Furthermore, in the RSPO Independent Smallholder Standard, Indonesia National Interpretation for the Production of Sustainable Palm Oil 2020, endorsed by the RSPO Board of Governors on 14 February 2022, it is stated that the maximum area of individual ownership is 20 Ha and the total area is the accumulation of total land ownership wherever it is located.

In relation to the above, at the time of the previous assessment, there were farmers who had land above 20 Ha, related to this, on June 1, 2022, the person concerned has been granted part of his land to other parties who are still members of the farmer group so that the current total area is not more than 20 hectares. Ha. The current grant process is in the process of being approved by the relevant agencies regarding changes to land ownership documents including STDB and SPPL. In this regard, the Kelompok Tani Tenera, is encouraged to continue to monitor the change process regarding the legal aspects of land ownership (OFI)

Milestone B

Based on documents verifications and interview with association managements it was known if the group manager has been maintain a list of members with their coordinates and maps. All smallholders / farmers members have legal or customary rights to use the land in accordance with national and local laws and customary practices as evidenced by the existence of documents showing the name of the farmer, legality of land ownership (SHM), coordinate points, geographical location, and map of plot locations.

Each plot has proof of land ownership in accordance with the land ownership documents. Based on the results of field visits, it is known that the farmers have been operating on their respective lands which are marked by the presence of stakes / markers between plots / land plots or other markers (trench, tree, midrib and so on).

All areas were has Land Ownership Certificate which issued by National Land Agency of Katingan Regency.

The members of was consist of surrounding community which generally has family relationship or relatives of Group Manager. Since the first time of smallholder operational on September 2004 and starting of Group operational on May 2017, it was reported that land conflict were never been happened. Hence, involvement of para-military for security maintenance was never been happened as well. This matter has confirmed during field observation and interview with community representatives from Village of Hampalit and Group members.

Documents verifications, interviews with associations management as well as farmers during field visit it was known if all members have signed and acknowledged membership requirements. All members prior joint with the association need to complete the requirements as a prospective member, among others copy id cards, land ownerships evidence, family identity cards as well as statement letter of RSPO Certification commitment as mentioned in annex 2 are:

- Not clearing or acquiring land from indigenous peoples, local communities, or other users without their free, prior and informed consent (FPIC), based on a simplified FPIC approach
- Resolve any existing disputes

The completeness document requirements for members have been checked and evaluated before joining and documented in the master list of farmer data which explains the completeness of member data. Associations can present several smallholders declarations / farmers' statement letters that been signed by members which interviewed during assessments.

Based on the results of field observations to smallholder's land parcels, it is observed that all the boundaries are clearly visible in the field, the boundaries formed in the form of poles or stakes. Based on observation, there was no planting beyond their land boundaries. Based on interviews with smallholders and the results of field observations there are no areas of smallholders who are in the process of dispute. furthermore, Group Manager ensure that group members lands are not claimed or contested by any third parties or local communities and there is no violation of customary rights and its confirmed with the result of public consultation with village head and plantation agency. If there is any land dispute, there will be go through the mechanism of communication and grievance.

Based on public consultation with plantation agency of Katingan Regency and Village Head of Hampalit obtained information if there are non report regarding land under member of Kelompok Tani Tenera. During audit Kelompok Tani Tenera present Disclosure Form for Land Tenure and Utilisation History and Presence of Land Conflict that known by Group Managers, based on auditor verifications it was known there are potential land conflict in the members land.

The Kelompok Tani Tenera conducted an internal training on June 7th, 2022, which was conducted by the Field Extension Unit for all employees, which was attended by 12 people at the Tenera Office. The training material presented was an understanding of auditing so that employees can understand the principles and criteria of the RSPO, including those related to operations, free employment of fair funds and no retention of identity documents, workers do not pay recruitment fees, no replacement of work contracts, no overtime work required. not voluntary, freedom for workers to resign, no penalty in case of termination of employment, no bonded work, and no withholding of wages. For example, there is evidence of payment of wages for the July 2022 period as many as 13 people who were paid on August 2, 2022, including Dwi Listiyaningsih as administration, Wahyudi as harvesting supervisor, Sukaryaji as harvester and Siti Sahdiah as farmer. In addition, based on the results of interviews with general employees and document review, it is known that salary payments to employees of Kelompok Tani Tenera are carried out smoothly and on time, this shows that there is no practice of withholding employee salaries

Milestone B

Based on an interview with Head of Kelompok Tani Tenera, it is known that all employees who work are residents around the plantation and there is no identity detention and can work according to the type of work and competence. Kelompok Tani Tenera shows a Work Agreement with FFB harvesting employees namely Purwanto dated January 1st, 2022, in work agreement states the duties and responsibilities of both parties including those related to work rules, wages, employee treatment referring to BPJS regulations, sick, permits leaving the work location, and resolving employee disputes. Based on the review of the document, there are no restrictions on access to employee identities and employees have freedom in accordance with work agreement

On June 7th, 2022, socialization related to understanding the principles and criteria of the RSPO was carried out, including the prohibition of child labor by the Field Extension Unit to all employees, which was attended by 12 people at the Tenera Office. Employees understand this and the rules related to the prohibition of child labor continue to be socialized to employees and farmer members of Kelompok Tani Tenera

Workers' pay complies with minimum legal requirements, mandatory industry standards as defined by national law or collective bargaining, whichever takes priority in local regulations.

The Pokan Tenera shows a list of employee wages for the period July 2022 for 13 people who were paid on August 2nd, 2022 total of Rp. 54,664,100. The employee's wages consist of a basic salary of Rp. 2,980,000. In addition to the basic salary, Kelompok Tani Tenera also provides a fixed monthly allowance of 550,000 in kind. In addition, Kelompok Tani Tenera provides Umrah for good employees, including harvesting employees and FFB drivers performing Umrah in 2022. Kelompok Tani Tenera shows proof of salary receipts including Dwi Listiyaningsih as Administration staf, Wahyudi as Harvester, Sukaryaji as Harvester and Siti Sahdiah as farmer. In addition, based on the results of interviews with general employees and document review, it is known that payments to members are carried out smoothly, this shows that workers receive wages according to the rules and without discrimination women

Workers understand their rights and freedom to file a complaint to group manager or relevant third parties, including RSPO.

Eligibility

The Kelompok Tani Tenera is committed to respecting the rights of workers to submit complaints so as to facilitate it through the procedure for submitting complaints with No. The KELOMPOK TANI_TENERA-SOP-K-25 document which was ratified by Head of Kelompok Tani Tenera on July 1st, 2017. This procedure includes a mechanism for resolving complaints from external parties and internal parties. Based on the results of interviews with workers, it is known that complaints can be submitted via sms, telephone or come to the Kelompok Tani Tenera

The Kelompok Tani Tenera has an internal training program for farmer members listed in the 2022 Kelompok Tani Tenera training program which was approved by Head of Kelompok Tani Tenera on January 03rd 2022. In the training program there are 4 types of training that are planned to be carried out in June 2022, namely harvest training, fertilization, spraying weeds, and mixing pesticides carried out by the Managers of the Kelompok Tani Tenera. The training program has been carried out including on June 9, 2022, training on mixing pesticides and weed spray was carried out for 4 spray employees and 1 spray foreman so that employees can practice how to mix pesticides correctly and ensure that employees wear complete PPE. In addition, there was socialization and handover of spray PPE carried out by the Kelompok Tani Tenera Extension Unit to 6 employees as an effort to mitigate the risks arising from the impact of using pesticides, including glasses, boots, aprons, spray masks, rubber gloves and helmet.

Kelompok Tani Tenera cooperates with "BM Medical" in conducting employee health checks which are carried out regularly every 1 year, while employees who use fertilizers and herbicides are carried out special health checks every 6 months. For example, there were 5 spray employees who had a special medical examination on August 12, 2022 with healthy results.

In addition, Kelompok Tani Tenera also includes its employees in the healthcare and social security agency. Kelompok Tani Tenera shows proof of payment for The Employment Social Security for 13 employees for the period July 2022, the payment code is 220702529114 with a value of Rp. 2,533,861 and proof of payment of Health Insurance for 12 employees for the period of June 2022 amounting to Rp. Rp. 2092,540. The other 1 employee already has health insurance in the form of a Healthy Indonesia Card

Milestone B

The Kelompok Tani Tenera is committed to ensuring the welfare of its employees, including through proper housing equipped with First Aid, Personal Protective Equipment (PPE) facilities for working employees, availability of water sources in employee housing and good toilets. Employees and families in Kelompok Tani Tenera housing can receive it easily and free of charge

- a. Farmers' statement letter of willingness to follow the RSPO certification as mentioned in annex 2
- b. Statement letter of Smallholder Declaration as mentioned in annex 2
- c. Statement letter of RSPO Certification commitment as mentioned in annex 2.

The Kelompok Tani Tenera can show a commitment document to protect HCV and HCS forests through a precautionary practice approach from each member which is contained in the statement letter of RSPO Certification commitment Kelompok Tani Tenera which has been signed by each member, the commitment is signed by each member members before joining.

Milestone A

Kelompok Tani Tenera already has a work program for the management of High Conservation Value Areas for the 2022 period. Some of the planned activities include socialization of HCV, monitoring of the prohibition of spraying in HCV areas, maintenance of HCV boundary fences, maintenance of HCV signboards and HCV training.

Kelompok Tani Tenera shows documentation of the maintenance and enhancement of HCV zones in the operational areas, for example:

- a. Minutes of socialization of the HCV area to employees on June 7, 2022, located at PAL IV and attended by 12 employees. Kelompok Tani Tenera can show documentation and attendance list for the socialization.
- b. Minutes of maintenance of the HCV sign board on 7 June 2022. Kelompok Tani Tenera can show documentation of the activity.

Milestone A

Kelompok Tani Tenera has demonstrated the realization of training to employees regarding the prohibition of using fire in plantation operations, for example the socialization on 7 June 2022 regarding the ban on the use of fire for pest control and waste management. The socialization was attended by 12 employees where the company could show documentation and attendance list for the activity.

Milestone B

Based on field observations and interviews with employees show that the Kelompok Tani Tenera has provided training to employees regarding the prohibition of using fire in field operations. It was further explained that during the audit activity, there were no replanting activities or new plantings

Based on interviews with administrators known that pest and disease control is carried out not using fire, but using natural enemies such as *Turnera subulata* for *UPDKS* and the use of pheromone traps for the Rhinoceros Beetle. In waste management, especially

domestic waste in workers' housing, organic and inorganic waste bins have been provided, which are routinely taken by garbage trucks to be disposed of at the landfill.

Kelompok Tani Tenera has a policy No 005 / P-TNR / SK / VII / 2017 dated 1 July 2017 to protect the water boundaries located within the area of the Kelompok Tani Tenera. The form of planning that is taken is not spraying around the river border area. In addition, Kelompok Tani Tenera can demonstrate a commitment not to carry out new plantings in the river area zone as stated in the statement letter of RSPO Certification commitment. The commitment has been signed by each member before joining.

Milestone A

Kelompok Tani Tenera identified areas with high conservation values in March 2017 conducted by Bumitama Gunajaya Agro (BGA) under the guidance of the RSPO for independent smallholders in managing high conservation values in established oil palm plantations (criterion 5.2), version 2.4, 9 December 2015. From the identification results, it is known that there is Lake Toman which is categorized as HCV 4.1. In this case, Kelompok Tani Tenera shows HCV management documents, including: installation of signs, socialization to employees and the surrounding community and planting of woody plants in the HCV area.

Kelompok Tani Tenera already has a SOP of HCV Management Program No. KELOMPOK TANI_TENERA-SOP-HCV-26 which includes instructions for HCV management where one form of management is by setting up a buffer zone boundary on HCV 4.1. Based on field observations in the area of HCV 4.1 Plot 11.03 it is known that the management of HCV is good enough but needs to be further improved regarding the buffer zone boundary. In this case, Kelompok Tani Tenera has the opportunity to confirm the buffer zone boundary marking in the HCV 4.1 area. OFI

Milestone B

Kelompok Tani Tenera shows documentation of the maintenance and enhancement of HCV zones in the operational areas, for example:

- a. Minutes of socialization of the HCV area to employees on June 7, 2022, located at PAL IV and attended by 12 employees. Kelompok Tani Tenera can show documentation and attendance list for the socialization.
- b. Minutes of maintenance of the HCV sign board on 7 June 2022. Kelompok Tani Tenera can show documentation of the activity.

Based on field observations on HCV 4.1 in Plot 11.03 found that HCV was well maintained. There is a warning board regarding the prohibition of the application of chemicals and there is also a fence that limits the HCV area.

Based on interviews with farmers, information was obtained that they have knowledge and understanding related to demonstrating the maintaining and restoring riparian and other buffer zones in accordance with procedures that are owned, for example not applying chemicals and doing manual upkeep. That information inline with the result of interviews with chemical application workers revealed that the workers had an understanding of the prohibition of chemical application in HCV areas.

Pesticides are used in ways that do not endanger health of workers, family, communities or the environment.

The Farmer Group has a commitment not to use group 1A and 1B herbicides contained in the Group Manager Decree number 008/P-TNR/SK/VIII/2017 dated August 3, 2017.

Kelompok Tani Tenera showed training documents on best management practices for pesticides, such as socialization and training on the risks of using, storing and disposing of used pesticide packaging which was held on June 9, 2022 and was attended by 12 employees. Kelompok Tani Tenera can show documentation, materials and attendance lists for the activity.

Based on interviews with spray workers who at the time of the audit worked for fertilizer activities revealed that Kelompok Tani Tenera always provides training to employees regarding the risks, use and storage of pesticides.

Milestone B

During the audit activity, there were no pesticide application activities in the field and only fertilization activities where the fertilization and pesticide applicator were the same person. Based on interviews with workers revealed that so far the pesticides used by Kelompok Tani Tenera are pesticides with the active ingredients *Methyl metsufuron* and *Glyphosate*. Based on field observations in the pesticide storage warehouse did not find any pesticides with the active ingredient *Paraquat dichloride* or pesticides categorized by WHO in class 1A or 1B.

- 2. Chemical training on 7 July 2022 which took place at the farmer group's office and was attended by 5 employees. Kelompok Tani Tenera can show documentation and attendance list for the socialization activity.

Based on interviews with fertilizer workers in Plot 1.11 revealed that Kelompok Tani Tenera always provides training to employees regarding the use of safe chemicals, IPM, and weed management

Milestone B

Kelompok Tani Tenera shows evidence regarding the use of an IPM approach to minimize the use of pesticides and herbicides in their estate by utilizing the beneficial plant type *Turnera subulata*:

- 1. Minutes of the Turnera subulate nursery on January 3, 2022 located at PAL 1.
- 2. Minutes of the Turnera subulate planting on March 7, 2022, located at PAL 11.
- 3. Minutes of treatment for Turnera subulate on June 1, 2022, located at PAL 11.

Based on field observations in PAL 5 and 8 revealed that Kelompok Tani Tenera had utilized the beneficial plant of the *Turnera* subulata type for controlling nettle caterpillar and also to minimize the use of pesticides.

Furthermore, in the RSPO Independent Smallholder Standard, Indonesia National Interpretation for the Production of Sustainable Palm Oil 2020, endorsed by the RSPO Board of Governors on 14 February 2022, it is stated that the maximum area of individual ownership is 20 Ha and the total area is the accumulation of total land ownership wherever it is located. In relation to the above, at the time of the previous assessment, there were farmers who had land above 20 Ha, related to this, on June 1, 2022, the person concerned has been granted part of his land to other parties who are still members of the farmer group so that the current total area is not more than 20 hectares. Ha. The current grant process is in the process of being approved by the relevant agencies regarding changes to land ownership documents including STDB and SPPL. In this regard, the Kelompok Tani Tenera, is encouraged to continue to monitor the change process regarding the legal aspects of land ownership (OFI)
