PT Perkebunan Nusantara III has applied to Mutuagung Lestari and will conduct Recertification at PT Perkebunan Nusantara IV with scope Berangir POM and its supply based, located at Perkebunan Berangir Village, NA IX – X Sub District, Labuhanbatu Utara District, Sumatera Utara Province, Indonesia against the requirement of Indonesia National Interpretation of the RSPO Principles and Criteria for the Production of Sustainable Palm Oil 2018 (INANI 2020).

Berangir POM – PT Perkebunan Nusantara IV has successfully been registered in the PalmTrace IT platform with member RSPO_PO1000004134. The organization is a member of RSPO and has been taking an active role in the RSPO certification processes and planned to maintain RSPO Sustainable Palm Oil requirement for all of its production. Mutuagung Lestari has arranged to conduct the assessment to the organization which operating 1 (one) palm oil mill and 1 (one) estate on **10 to 14 July 2023**.

PKS Berangir is a unit of PT Perkebunan Nusantara IV and is a subsidiary of PT Kebun Nusantara III (Persero). PT. Perkebunan Nusantara IV (Persero) Berangir Business Unit is one of the business units located in the plantation village of Berangir Kee. NA XI -X Kab. North Labuhan Batu. Prior to 1974, the Berangir plantation was a rubber plantation managed by PT. Wongso Rubber Coy and PT. Beautiful Son. In 1974 it was taken over with compensation by PNP VI in accordance with the domestic decision letter dated November 13, 1974 No: SK/32/HGU/DA/1974 which was recorded in the sub-agrarian office level II Labuhan Batu No. II and registered on June 26, 1975 with Number: 505/1975. Based on government regulation No. 9 of 1996, PT. Nusantara Plantation held a merger and PT. Perkebunan Nusantara VI is incorporated in PT. Perkebunan Nusantara IV (Persero) and later its name was called PT. Perkebunan Nusantara (Persero) IV Berangir business unit with oil palm commodity. The management of the Berangir business unit is divided into 6 and there is one palm oil mill with a capacity of 30 tons/hour.
