PT Agro Bukit is a member of RSPO and has been taking an active role in the RSPO surveillance processes and implementing programme to maintain RSPO Certified Sustainable Palm Oil. Mutuagung Lestari has arranged to conduct an assessment to Sungai Binti POM – PT Agro Bukit which operating 1 (one) palm oil mill and 4 (four) estates on **09 to 13 October 2023**.
