PT Nabire Baru is a member of RSPO and has been taking an active role in the RSPO surveillance processes and implementing programme to maintain RSPO Certified Sustainable Palm Oil. Mutuagung Lestari has arranged to conduct an assessment to Nabire Matoa POM – PT Nabire Baru which operating 1 (one) palm oil mill, 4 (four) estates and 3 smallholders (307 members) on **06 – 14 November 2023.**
