Bumipalma POM – PT Bumipalma Lestari Persada has successfully been registered in the Palm Trace IT platform with member RSPO_PO1000001064. The organization is a member of RSPO and has been taking an active role in the RSPO certification processes and planned to maintain RSPO Sustainable Palm Oil requirement for all of its production. Mutuagung Lestari has arranged to conduct the assessment to the organization which operating 1 (one) palm oil mill, 2 (two) estates on **08 January to 12 January 2024.**


