All shares have been fully paid-up by the new shareholders resulting from the Non-Preemptive Rights Issue to the Company prior to the issuance/distribution of the shares.

Upon the implementation of this Private Placement (PMTHMETD), the total number of issued and paid-up shares of the Company will increase from 3,142,950,585 (three billion one hundred forty-two million nine hundred fifty thousand five hundred eighty-five) shares to 3,452,228,885 (three billion four hundred fifty-two million two hundred twenty-eight thousand eight hundred eighty-five) shares.

Accordingly, following the completion of the Private Placement, the Company's issued and fully paid-up capital will increase from IDR 78,573,764,625 (seventy-eight billion five hundred seventy-three million seven hundred sixty-four thousand six hundred twenty-five Rupiah) to IDR 86,305,722,125 (eighty-six billion three hundred five million seven hundred twenty-two thousand one hundred twenty-five Rupiah).
